School Improvement Results Reporting | 2023-24

Each year, schools capture evidence of continuous improvement towards the goals set. In accordance with Alberta Education's Requirements for School Authority Planning and Results Reporting, schools then provide assurance to school communities by communicating student growth and achievement in an annual report that demonstrates improvement results and next steps. These results support continuous improvement of the quality and effectiveness of education programs provided to students while also improving student learning and achievement (Funding Manual for School Authorities 2024-25 School Year p. 196).

This report includes results relative to the goals and outcomes set in the 2023-24 School Development Plan and the school's Assurance Survey results.

School Improvement Results

Our School Focused on Improving

Our areas of focus:

- Writing
- Mathematical problem solving
- Citizenship

We chose to focus in thee three areas as the data collected pointed to gaps in learning. This data included report cards, school and system surveys, and provincial assessments including the LeNS, CC3 and Numeracy.

<u>Outcome for Writing</u>: Providing opportunities for students to receive and give feedback from others. In the OurSchool Survey 55% of students responded that they have opportunities to receive feedback from others in writing.

<u>Outcome for Math</u>: Our focus is for students to have increased levels of enjoyment and engagement in solving challenging problems. OurSchool Survey identifies a gap in students' enjoyment of working on challenging problems and their confidence in Mathematics. Similarly, students indicated a lack of interest in the mathematics that they are learning.

<u>Outcome for Citizenship</u>: The develop the school community's understanding of what it means to be a citizen of Killarney

What We Measured and Heard

We used the provincial Numeracy assessments along with system and school surveys to measure growth in the area of mathematics. We used CBE Student Survey and the Assurance Survey to measure changes in citizenship and mathematics engagement.

We noted the following improvements in the area of At Risk in Mathematics:

Mathematics Data - Survey

I am confident that I can learn mathematics – 85% agreement

I enjoy working on challenging problems in mathematics – 58% agreement

I think deeply and slowly when solving mathematics problems – 73% agreement

Writing Data - Survey

I am a good (competent) writer – 88% agreement

I know what to do next to improve my writing skills – 78% agreement

Citizenship Data:

I feel included at school 75% agreement

I feel welcome at school 79% agreement

My teachers want me to be successful 92% agreement

I am proud to be part of my school 82% agreement

School connectedness and belonging – 82% overall agreement

Assurance Survey:

Great improvement on the Assurance survey in terms of Citizenship. We have a 6 percentage point increase from Spring 2023 results.

Analysis and Interpretation

What We Noticed

We are noticing an increase in student perception of belonging at school as well as feeling safe at school. Students are also excited about the learning offered to them of Indigenous ways of knowing, being and doing. They like the work we have done with Indigenous Elders and storytellers. Post Covid we continue to see a deficit in mathematical knowledge. Students tell us that they are confident they can succeed in mathematics but are not as engaged in problem solving as we would like to see.

Celebrations

- Significant improvement in citizenship indicator (6 percentage point increase)
- Positive improvement in students feeling success in reading and writing
- Increase in students feeling connected and a sense of belonging at school
- 92% of students feel that their teachers want them to be successful

Areas for Growth

- Improved student engagement in mathematics
- Stronger connection between formal assessments and report card indicators
